'RAKSHITHA' PROGRAMME'

25.08.08

The CEO, ED and PC INHP of this organization went to Hyderabad and attended the meeting at HLPPT wherein instructions were issued about selection of 5 Mandals and 10 villages in each Mandal for arranging orientation to women folk of

age group of 15 to 35 years in rural areas for promoting male condoms. It was also directed to appoint the following persons for successful implementation of the project.

1. Women facilitators
2. Women Co-facilitators
3. Women Mobilizer for each Mandal

and to train them at Head office 'KRUSHI' on 08.09.08 on condom promotion to have precautionary measure for giving instructions on the subject matter. It was also stated that motivates should be women only. The said organization selected only 3 District in AP on pilot basis. The main objective of the project is to promote male condoms in rural areas. It was decided to conduct the field level orientation with effect from 07.08.08 to 15.09.08.

27.08.08

An annual review meeting on INHP subject was conducted by CARE Regional Manager. Shri Ravindranath, and also District programme officers of CARE Branch officer Karimnagar in Head office, "KRUSHI" in which, CEO, ED, PC INHP and all the BC's of INHP participated.

The RM has stated that the following 3 Blocks will be phased out by the end of Sep'08 and therefore the BC's should ensure that

1. Peddapally
2. Jagitiyal
3. Mallial

All the Health activities in these Block areas to be continued as usual even without the support of BC's concerned from CARE after 30.09.08. The RM and District Programme officers CARE urged the need to put more efforts for value addition work in each of the Blocks in health activities and to show substantial progress in NHD and to eradicate malnutrition in rural areas. It was also directed that much focuss to be given on other Blocks for substantial progress on Health items and also to reduce the malnutrition status in other Block areas which are also going to be phased out by the end of Feb'08.

29.08.08

The District CARE Programme officers Karimnagar have conducted a re-orientation training to all the BC's in their office to enlighten them selves to have ample knowledge on their prime roles and responsibilities to show better progress in the ensuing month on Health activities.

'RAKSHITHA' PROGRAMME

13.09.08

The programme office, 'RAKSHITHA' from HPLLEP organization Hyderabad gave orientation to the facilitators appointed for promoting male condoms in rural areas.

15.09.08

Sri BRL Swamy, PC INHP of this organization has taken 16 Ashaworkers from various PHC's of the District to St. John's seminary Hyderabad to give them orientation on 'RAKSHITHA' programme for promoting condoms process in rural areas by HPLLFP organization Hyderabad. They were enlightened about the very importance of the programme and also the implications involved for wide publicity at rural areas and also about their own roles and responsibilities as the facilitators of the programme at village level as social mobilizers to create awareness on usage of condoms by males in the rural areas.

24.09.08 to 29.09.08

An orientation cum workshop was conducted by HLPPT organization Hyderabad in their office with selected NGO's of 3 Districts in Andhra Pradesh on 25-09-08. In this workshop instructions were given to select 10 villagers in each of the selected Mandals in each District for arranging orientation to women folk with age group of 15 to 35 years in rural areas while appointing the following persons from 'ASHA WORKERS' in the villages

1. Facilitator
2. Co-Facilitator
- and 3. Mobiliser

to motivate rural women folk on usage of promoting condoms as a preventive measure for HIV AIDS. Accordingly, this organization has selected 10 villages in each of the following five Mandals in Karimnagar District as per statement appended.

1. Siricilla
2. Illanthakunta
3. Mustabad
4. Yellareddypet
5. Gambhiraopet

A schedule programme has been chalked out from 24.09.08 to 29.09.08 and given orientation on usage of condoms to the rural women 'ASHA WORKERS' who were appointed as facilitators/Co-facilitators details the number of women participated in the orientation classes in each village etc. are shown in the statement appended.

An amount of Rs. 1, 69,323/- (Rupees One Lakh Sixty Nine Thousands Three Hundred and Twenty Three Only) was incurred for successful conduct of this programme in the selected villages from the available funds of this organization.

The proposals for the reimbursement of the said amount along with the details of expenditure incurred were submitted to Ms V. Padmavathi, Programme officer, HLF PPT, 'RAKSHITHA' Basheer Bagh, Hyderabad vide this office reference no 02/Rakshitha/08 dated 30.09.08.

The relevant photos and other bills were also sent with expenditure particulars.

BLOCK REVIEW MEETINGS:-

The Block Co-ordinators have attended 20 Block review meetings along with supervisors. They are facilitating in the review meeting about the gap's identified during their field visits, like Malnutrition status, record maintenance, AWW home visit tool. Immunization due list, strengthening of NHD's and also facilitation in preparation of sector meeting's agenda, BLAC meeting agenda. Mandal convergence meetings, SNP, pre-school activity.

PRE-SECTOR MEETINGS:-

9 Pre sector meetings are attended during the month out of 11 Projects and support given to CDPO's and supervisors on identified issues like Malnutrition, Immunization CF with Quality, Quantity and Frequency and AWC joint visit observations and preparation of common agenda for conducting sector meetings.

SECTOR MEETINGS:-

During the month, the BC's have attended 33 sector meeting and facilitated supervisor for strengthening of review meetings at sector level on the following issues.

1. New born care
2. Malnutrition status
3. AWW House visit tools
4. Referring Institutional deliveries
5. Awareness on the maintenance of minutes registers and reviews machanisam.
6. To support weak and new supervisor to create awareness to strengthen the review mechanisam and also about correct maintenance of various records.
7. To identify the low performance AWC's and to prepare action plan for joint house visits to bring change in the best practices like new born care, Complementary feeding exclusive breast feeding and timely immunization.

PHC Level Meeting

In every month the BC's are participating in ASHA workers meeting along with ICDS supervisors to discuss the identified issues from joint house visits and NHD's on the following points.

1. PRI's participation in NHD's and various important celebrations like breast feed celebrations nutritional week celebrations and health camps and other innovative programmes
2. Preparation of due list for 100% immunization in NHD's

3. Developed Co-ordination between ANM, AWW and CBO's to provide best services to the beneficiaries
4. To motivate regular NHD's at public convenient places like Gramapanchayath, AWC, and PHC sub centers etc.
5. To focuss on giving complete consumption i.e 5 dosage of vitamin 'A' by children of age grump of 01 to 03 years.
6. To facilitate the MO's for identifying the gaps on immunization at village level and also to strengthen the joint visits of ANM and AWW's.

Convergence

1. Mandal level convergence meetings with IKP Health and ICDS workers are being conducted in all the Blocks regularly to create awareness on nutrition and Health activities and also to support PRI representatives for regular attendance in NHD's
2. All the BC's have attended the 'ASHA' worker meeting held at PHC level and given orientation on Nutrition and Health activities.
3. BLAC meeting was conducted at ICDS office Peddapally Block on 23.09.2008. The concerned MO's/ICDS PO's and supervisors attended this meeting and discussed on gaps identified with regard to strengthening of NHD's LHV supervisors joint visits MO's and CDPO's joint visits and prepared the action plan for implementing the above issues effectively.

Nutrition week celebrations

The ICDS CDPO's have resolved to celebrate nutrition week celebrations at Mandal level/ Sector level and Village level with effect from 01.09.2008 to 07.09.2008 and also conducted these celebrations successfully by involving PRI's and CBO's. The BC's have also attended in 39 celebrations in the District.

The following important events took place in these celebrations

1. Demonstration of stalls on nutritious food
2. Conducting awareness meetings on importance of nutrition and Health activities
3. Rallies and cultural activities were conducted with school children at District level.
4. Gifts were given by donor (PRI's and CBO's) to the beneficiaries.
5. All the Sarpanches/MPTC's/MPP's and also ZP Chairman Municipal chairman along with Councilors and CARE officials also attended these programmes.

BLOCK REVIEW MEETINGS:-

The BC's of this organization have attended the Block review meetings and facilitated the CDPO's about gaps noticed by them like 1. Behavioral changes among mothers best practices like BPP, New born care and quality quantity frequency etc.

and requested the CDPO's concerned to take action for improvement on the above issue by conducting frequent visits/ reviews with AWW's in their areas.

Block Level review meetings are being conducted as there is no regular CDPO for Manthany Block. This matter was brought to the notice of care officials and also PD, ICDS for taking necessary action.

There are only 3 ICDS supervisors working in Mahadevpur Blocks who are not visiting and covering entire area of the block. But due to the efforts made by BC of this organization there is improvement in Health and ICDS activities consequently, the ANM's in the area are sensitised about prioritisation of house visits, innovative programmes like 'ANNA PRASANA' and timely immunization of below 2 years children and improvement of NHD's etc.

The CDPO's are reviewing the progress on achievement sector wise so that the issues and gaps are being identified easily. The main focuss was given on the following issues.

1. Behavioral changes on complementary feeding given to children of age group above six months
2. Identifying gaps to take up timely immunization
3. Attending of PRI representatives in NHD's
4. Village Level and Mandal Level convergence meetings to be improved.
5. Preparation of action plan to identify the low performance of AWC's and to give them CB for improvement

PRE-SECTOR MEETINGS:-

Since there are no regular CDPO's in Manthany and Mahadevpur Blocks, these pre-sector meetings were not conducted in the month of Oct'08. However, the supervisors are still following the common agenda of previous month. The BC's of this organization facilitated the ICDS supervisor for improvement in Health and ICDS Activities.

The BC's of this organization have insisted the ICDS CDPO's to follow the common agenda fully to identify gaps if any for implementation in sector meetings.

SECTOR MEETINGS:

All BC's have participated in 27 sector meetings during this month both in FY 09 and Replication Blocks and facilitated the supervisors for effective review with AWW's on the following issues.
