ANNUAL PROGRESS REPORT ON I W D P - II

08.04.08

Shri D.R. Prasad WDT (Social) was instructed to prepare the list of farmers who are beneficiaries along with the area benefited under 'Theegalakunta' proposed for civil work in Thurthy village, both under SCW & DCW lands in the village. He was also asked to prepare the list of farmers who are willing to adopt NPM practices for ensuing Kharif season and to furnish the list to the organization with in a week's time.

The entire watershed team has been directed by CEO to visit the following watershed areas to identify and furnish the breached sources if any by inspecting the PE & EP activities with in a week's time. 1. Kalikota 2. Ippapally 3. Chinthakunta I & II.

It has been decided to address the PD DWMA duly explaining the local condition of Rudrangi watersheds so as to surrender the outstanding PE & EP amounts to be kept at the disposal of the VO's concerned till the vaccines of both the Chairman and Secretary are filled up. The concerned PC was instructed to attend to the following item of work with in a week's time.

- 1. To prepare detailed expenditures statement under each watershed area and area at actual balance amount for utilization to meet the genuine demand by V.W.C.
- 2. To circulate a note on excess expenditure if any booked for civil works to send proposals and to send the UC's to DWMA authorities.

The WDT tech. was asked to visit 1. Thurthy 2. Chintakunta I & II to prepare estimates for civil works feasible and genuine one after interacting with VWC and to submit them with in a week's time.

09.04.08 and 10.04.08

Shri T. Narender PC, and Shri K. Murali WDT (Tech.) of this organization and ED of this organization have attended the two days workshop on IGWDP watersheds in which the role of each organization viz NABARD, RODECCO and CMP were discussed along with the role of WDT's, PC's etc. Shri Srikhar from NABARD Rodecco officials CMP officials and also NGO's from the entire state have participated in this workshop.

23.06.08

The CEO conducted a review meeting with ED, PC and WDT's of watershed scheme in the Head office and issued the following instructions.

- 1. To take action for refund of the amounts available under NRM and to reallocate the same to PE and EP activities (A letter to go to PD DWMA).
- 2. Verification of watershed civil corks in all the (09) watershed areas and to submit a special report on the condition of different civil work by dividing watershed team in to two groups as fallows.
- i. Chinthakunta I and II

ii. Ippapally PC and WDT of watershed

iii. Potharam

iv. Rudrangi East and West

v. Kalikota Sri Murali WDT (Tech)

vi. Thurthy Sri Rajendraprasad WDT (Social)

It was also directed to send the UC's for the remaining amount of Rs. 4.10 lakhs. The PC has been asked to expedite the submission UC's for balance amount to the PD DWMA.

The CEO and ED and PM of IWDP KRMR approached the OD DWMA Karimnagar in collector's complex and ascertained about the instructions to be followed in re-allocation of PE and EP amount from NRM funds of all the (09) watersheds being dealt by this organization under IWDP-II and also about the UCS status under the project.
